A separated challenge will be the programming of the 11 European Development Fund. On the regional note, I will pursue a real and substantial Caribbean integration. When it comes to the managerial challenges, I will encourage all the three Delegations' staff to identify themselves with the EU ideas, to be dedicated to the service and I will improve the working atmosphere in the sense of team building. I will, indeed, represent the European Union in Guyana, Suriname, Trinidad and Tobago, Aruba, Bonaire, Curacao, Saba, Sint Eustatius, Sint Maarten and Caricom/Cariforum in accordance with the mandate given to me by the Headquarters.
